

**IOWANS FOR MEDICAL MARIJUANA  
RESTATED ARTICLES OF INCORPORATION  
MARCH 20, 2024**

ARTICLE ONE. The name of this corporation is Iowans for Medical Marijuana. Iowans for Medical Marijuana is organized under the Iowa Nonprofit Corporation Act, Chapter 504A of the Code of Iowa.

ARTICLE TWO. The period of duration of this corporation is the have continuance forever and perpetual succession by the name of Iowans for Medical Marijuana.

ARTICLE THREE. The purposes for which this corporation is organized are: (A) to obtain a federal exemption for Iowa's medical cannabis patients, Iowa Code Chapter 124E, similar to the federal exemption for the religious use of peyote in 21 C.F.R. 1307.31, Iowa Code Section 124.204(8); (B) to amend the definition of cannabidiol in Iowa Code Section 124E.2(10) to be scientifically accurate, a single cannabinoid cannabidiol; (C) to change the name of Iowa's medical cannabis program from "The Medical Cannabidiol Act" to "The Medical Cannabis Act" to reflect reality; and (D) to educate the public regarding the current unethical practice by the Iowa legislature of authorizing federal racketeering organizations to operate cannabis businesses in Iowa without federal authorization.

ARTICLE FOUR. This corporation is not organized for a pecuniary profit. It will not have the power to issue certificates of stock or declare dividends, and no part of its net earnings will inure to the benefit of any member, director, or individual. The balance, if any, of all money received by the corporation from its operations, after the payment in full of all debts and obligations of the corporation of whatever kind or nature, will be used and distributed exclusively to the Ethiopian Zion Coptic Church, 130 E Aurora Ave, Des Moines, Iowa 50313-3654, Telephone (515) 343-9933. The Ethiopian Zion Coptic Church is a non-profit corporation registered in the State of Iowa.

ARTICLE FIVE. The physical address of the corporation's initial registered office in the State of Iowa is 130 E Aurora Ave, Des Moines, Iowa 50313-3654. The mailing address of the corporation's initial registered office is 130 E Aurora Ave, Des Moines, Iowa 50313-3654. The name of the initial registered agent is Carl Olsen.

ARTICLE SIX. The corporation has three initial directors: (A) Carl Olsen, 130 East Aurora Avenue, Des Moines, Iowa 50313-3654; (B) George McMahan, Livermore, Iowa; and (C) Barbara

Douglass, Lakeside, Iowa. Mr. McMahon and Ms. Douglass are both deceased since the original incorporation in 2006.

ARTICLE SEVEN. The conditions and regulations of membership and the rights and other privileges of the classes of membership will be determined and fixed by the bylaws.

ARTICLE EIGHT. The private property of the members of this corporation will not be liable for its corporate debts.

ARTICLE NINE. This corporation will never mortgage or place a deed of trust or other lien on any of its properties for any purpose, nor will it, save for current expenses, incur indebtedness at any time during its existence.

ARTICLE TEN. Notwithstanding any other provision of these articles, the corporation will not carry on any other activities not permitted to be carried on; (A) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Code section); or (B) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Code section).

ARTICLE ELEVEN. Notwithstanding any other provision of these articles, this corporation will not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE TWELVE. No substantial part of the activities of the corporation will be devoted to the carrying on of propaganda, and the corporation will not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

ARTICLE THIRTEEN. No act or proceedings of the corporation will be invalidated by reason of any vacancy in the body or in any of the offices or by any defects in the appointment of any person to any such office.

ARTICLE FOURTEEN. The corporate began existence on October 1, 2006.
