Pursuant to Federal Rule of Appellate Procedure 28(j), we write to inform the Court of a correction to the Notice of Application, 84 Fed. Reg. 44920 (Aug. 27, 2019), that was discussed in our response brief on pages 4-5.

In the Notice of Application, the U.S. Drug Enforcement Administration (DEA) identified 33 applications it had received that sought permission to manufacture, in bulk, marijuana (drug code 7360), marihuana extract (drug code 7350), and tetrahydrocannabinols (drug code 7370). 84 Fed. Reg. at 44922-23. On October 11, 2019, DEA published a correction to the Notice, explaining that "certain drug codes for some of the applicants were inadvertently omitted by DEA or not listed because applicants had inadvertently omitted them from their applications." 84 Fed. Reg. 54926 (Oct. 11, 2019). The correction added drug codes for ten applicants, including petitioner Scottsdale Research Institute. *Id.* (correcting Scottsdale's application to include marijuana (drug code 7360) and tetrahydrocannabinols (drug code 7370)). The correction did not change the Notice's deadline for receiving comments on or before October 28, 2019.

Bulk Manufacturer of Controlled Substances Applications: Bulk Manufacturers of Marihuana; Correction

ACTION: Notice of applications; correction.

SUMMARY: The Drug Enforcement Administration (DEA) published a document in the **Federal Register** on August 27, 2019, concerning a notice of applications. As that document correctly indicated, each of the applicants noticed applied to be registered with DEA to grow marihuana as a bulk manufacturer. However, certain drug codes for some of the applicants were inadvertently omitted by DEA or not listed because applicants

had inadvertently omitted them from their applications.

Notice of Lodging of Proposed Consent Decree Under the Clean Air Act

On September 30, 2019, the Department of Justice lodged a proposed consent decree with the United States District Court for the Eastern District of Virginia in the lawsuit entitled United States and the Commonwealth of Virginia v. KmX Chemical Corporation, Civil Action No. 2:19–cv–00517–AWA– DEMVAED.

The Complaint filed by the United States and the Commonwealth alleges claims under the Clean Air Act and seeks injunctive relief and civil penalties for violations of the leak detection and repair regulations that govern at the KmX Chemical Corporation's chemical reclamation facility in New Church, Virginia. The consent decree requires the defendant to perform injunctive relief and pay a \$60,000 civil penalty.

The publication of this notice opens a period for public comment on the consent decree. Comments should be addressed to the Assistant Attorney General, Environment and Natural Resources Division, and should refer to United States and the Commonwealth of Virginia v. KmX Chemical Corporation, D.J. Ref. No. 90–5–2–1–11442. All comments must be submitted no later than thirty (30) days after the publication date of this notice.
